New Business

1. Estate Gift of \$200,000– Bequest from the Trust of Ellen Juul. The council approved : 10% tithe would be \$16,000 for Mission Projects and \$150,000 to the Principal Mortgage. The Church in the World committee proposed four different groups to receive the money for Mission Projects: **1.** Katie Weikle /Germany Mission - \$5,000 to help with a building project **2.** Estonia for Seminary - \$5,000 **3.** Wings (Local Mission for Children entering Foster Care: clothing, stuffed animal, toiletries etc) - \$2,000 for rent for storage **4.** New Hope Missions - \$4,000 for a Dormitory. ACTION – M/S/P to approve the Tithe amount for Missions.

2. Summer Intern Proposal: Requesting 2 paid interns – Combined Children and Youth Internship and Marketing and Design Internship.

3. Pastor Dave reports the lists that were made for the 150th Anniversary ideas were given to the Task Force. There were many great ideas. Mary Hodson and Joy May will be co-chairing. They will be meeting monthly and may create sub teams from the larger group.

4. Reminder that Pastor Dave is taking Sabbatical.

5. Pastor Paul is proposing a total of 9 weeks off for the summer to take time to reflect and report back in the Fall on his decision to remain on staff with his duties he has now. Pastor Paul's proposal is that he would not be paid for three pay periods. As a contract employee, he doesn't receive any paid time off.

The Correspondence box had a Thank You from ILT for our support, Thank You from New Hope Mission for our March gift, and a Thank You from Augustana Dist/Congregation in Tabor for the support of their Ministry.
