- Fundraisers usually total around \$6,500, will not do Valentine's Dinner or Palm Sunday breakfast this year
- New ideas to replace funds include a coffee fundraiser, Choice dollars from Thrivent members, budgeted scholarship money and sponsoring a participant. More information to come.

2024 Budget Recommendation for Annual Meeting

- 5.6% increase in spending due in part to benevolence rising because of 2023 giving, website revamp
- 4.8% increase in offerings from 2023. The rest will be from a projected rise in ministry revenue.
  - M/S/C to recommend 2024 proposed budget to the congregation at the annual meeting
